### Attendance/Absences

The student must be on time for the classroom portion of the contract. If the student fails to attend more than 15 minutes of classroom instruction, the student's enrollment will be terminated and will have to re-schedule this portion. \_\_\_\_\_ **(INITIAL)**

There will be a \$ 25.00 nonrefundable charge applied for any no-show or missed scheduled classroom or driving appointment. The fee must be paid before the student is allowed to schedule any further appointments. In case of an emergency or illness, the student must contact the instructor within 24 hours prior to the scheduled appointment to avoid any charges. \_\_\_\_\_ **(INITIAL)**

### Cancellation Policy

A full refund will be made to any student who cancels the enrollment contract before midnight of the **3<sup>rd</sup> day** (excluding Saturday, Sunday, & legal holidays) after the enrollment contract is signed by the prospective student unless the student has completed the course & accepted a certificate of completion during that period. \_\_\_\_\_ **(INITIAL)**

### Refunds

If tuition is collected in advance of entrance & if after the expiration of the 72-hour cancellation privilege, the student fails to attend the class, terminates, or withdraws, the school may retain up to \$20 as administrative expenses; & for the remainder, shall refund that portion of the behind-the-wheel tuition & fees for services not previously received by the student.

A full refund of tuition & fees is due & refundable if:

- (a) an enrollee is not accepted by the school.
- (b) if the course of instruction is discontinued by the school at this location.
- (c) if the student's enrollment was procured because of any misrepresentation in advertising, promotional materials of the school, or misrepresentation by the owner or of the school. \_\_\_\_\_ **(INITIAL)**
